

**Provision of the Dean No. D 58  
on the Amount of Scholarship for the Doctoral Study  
Programmes  
from 1 April 2013, in the wording of 12 January 2015**

In accordance with Article 62, Paragraph 1, letter i) of Act No. 111/1998 Coll., Article 91, Paragraph 4, Letter c) of the same Act, and Article 3, Paragraph 3, Letter a) of the Scholarship Rules of the University of South Bohemia in České Budějovice and in reference to the communication of the Bursar of USB on the amount of the dedicated fund for basic scholarship of students on the doctoral study programmes in the year 2013, I hereby set for the period beginning on 1 April 2013 the amount of the basic scholarship for full-time students in the doctoral study programme in the standard period of study as follows:

From the above stated date a student of the doctoral study programme is to attain a basic scholarship (as stated by Article 91, Paragraph 4, Letter c) of Act No. 111/1998 Coll.) of:

1. CZK 6 500 /in words: six thousand five hundred Czech crowns/ per calendar month for a student in the first six month of study and further for students in the thirteenth and other months of study, on the condition that he/she has fulfilled the duty of submitting their literature review on the subject of his/her dissertation and presenting the plan and methodology of his/her dissertation at a seminar of the appropriate department or institute;
2. CZK 1 000 /in words: one thousand Czech crowns/ per calendar month for students in the thirteenth and further months of study who have yet to fulfil the duties stated in Paragraph 1 or have failed to fulfil other study duties;

Students who have already attained the credit for literature review and for the methodology seminar presented at the appropriate department or institute, have fulfilled the regular study duties and other conditions as detailed in the Rules for Study, and presented the results of their scientific work<sup>\*)</sup> in the following ways, may, at the proposal of the supervisor, receive a higher basic scholarship as follows

3. CZK 7 500 /in words: seven thousand five hundred Czech crowns/ per calendar month under the condition that he/she has presented a poster at an international conference<sup>\*\*)</sup> or are joint author of an article in a journal with an impact factor.
4. CZK 8 000 /in words: eight thousand Czech crowns/ per calendar month under the condition that they have lectured at an international conference<sup>\*\*)</sup>;
5. CZK 8 500 /in words: eight thousand five hundred Czech crowns/ per calendar month on the condition that they have published the results of their scientific work as the main author in a journal with an impact factor.

Students who are provably financially covered by their own scholarship or salary within the terms of an international contract are not eligible for a basic scholarship.

<sup>\*)</sup> the student is obliged to state his/her affiliation to the faculty on every document or publication arising from work on the dissertation thesis. In the case of request for an increase in the amount of a scholarship, the student is to prove the fulfilment of this duty by submitting a copy of the page of the article or the poster where the affiliation is stated.

<sup>\*\*)</sup> an international conference is understood to be a conference at which the language of communication is either English or another world language.
